have passed every Regents exam in all subject areas, thereby earning Advanced Regents diplomas and making Bedford Academy's graduation rate ninety-six percent; and

WHEREAS, The athletic talent displayed by this team is due in great part to the efforts of Coach Robert Phelps and his team of outstanding assistant coaches, skilled and inspirational tutors, respected for their ability to develop potential into excellence; and WHEREAS, The team's overall record is outstanding, and the team

members were loyally and enthusiastically supported by family, fans,

friends and the community at large; and
