WHEREAS, During her years as the hospital's senior vice-president and chief operating officer, Darlene Burns played a significant role in the development of new services to meet the community's needs, including the hospital's 14-bed rehabilitation unit and its 11-bed senior behavioral health unit; under her leadership as CEO, the hospital recruited several new physicians and made significant investments in its infrastructure; and
