WHEREAS, Attendant to such concern, and in full accord with its long-standing traditions, this Legislative Body is justly proud to honor the Asian American Restaurant Association (AARA) upon the occasion of its Lunar New Year celebration on March 2, 2011; and

WHEREAS, The Lunar New Year is the most important and most popular of festivals observed by Asian Americans; it is always greeted with much preparation and much celebration; and

WHEREAS, In keeping with that tradition, the Asian American Restaurant Association will proudly host a festive Lunar New Year celebration welcoming the Year of the Rabbit 4709 at New York City's Jade Asian Restaurant on Wednesday, March 2, 2011; and

WHEREAS, The Asian American Restaurant Association was founded by renowned chefs and restaurant owners who are dedicated economic activists for New York City; and

WHEREAS, AARA represents and promotes the Asian restaurant industry; it works diligently to raise the level of professionalism within the industry and to heighten awareness of the importance of food safety education throughout the restaurant and foodservice industry; and

WHEREAS, AARA advocates on behalf of Asian restaurant owners, offers and encourages mutual support among members, conducts research for group insurance plans and seeks employment for workers and for restaurant
