WHEREAS, The Head Coach of the 2010-2011 New York Mills Varsity Boys' Basketball Team, Mike Adey, is to be inducted into the New York State Basketball Hall of Fame; Coach Adey's record in 30 years as a high school basketball coach is an outstanding 462-156, and his record at New York Mills in 13 years is 238-59; and

WHEREAS, The athletic talent displayed by the 2010-2011 New York Mills Varsity Boys' Basketball Team is due in great part to the efforts of Head Coach Mike Adey, Associate Head Coach, Brian Adey, and Assistant Coaches, Charlie Ferguson, Michael Keating and John Stevener; skilled and inspirational mentors, respected for their ability to develop poten-

tial into excellence; and

WHEREAS, The team's overall record is outstanding, and the team members were loyally and enthusiastically supported by family, fans, friends and the community at large; and
