WHEREAS, A distinguished Nassau County Police Officer, Geoffrey J. Breitkopf exemplified what it truly means to give of himself in providing vital police services in keeping with the noble mission of the Nassau County Police Department; and

Breitkopf is survived by his wife, Paula Cunningham Breitkopf; two sons, Connor and Owen; his parents, Jeffrey and Patricia Breitkopf; one brother, Kevin; parents-in-law, William and Dolores Cunningham; and brother and sisters-in-law, John, Janet, Theresa and Donna, as well as many nieces and nephews; in addition, he was predeceased by his brother, Heath; and

WHEREAS, Armed with a humanistic spirit and imbued with a sense of compassion, Nassau County Police Officer Geoffrey J. Breitkopf leaves

behind a legacy which will long endure the passage of time and will remain as a comforting memory to all he served and befriended; he will be deeply missed and truly merits the grateful tribute of this Legislative Body; now, therefore, be it
