WHEREAS, Robert N. Taub, M.D., Ph.D. is the Vivian and Seymour
Milstein Family Professor of Clinical Medicine at Columbia University's
Columbia College of Physicians and Surgeons; and
WHEREAS, He also holds the esteemed position of Director of Columbia's
Mesothelioma Center, and is the Attending Oncologist of Columbia University Medical Center; and

WHEREAS, Dr. Robert Taub is a medical oncologist and hematologist with a special interest in the diagnosis, clinical care, and investigation of patients with malignant mesothelioma and soft tissue sarcoma; and WHEREAS, This remarkable doctor received a Bachelor of Arts degree from Yeshiva University, in New York, and a medical degree from Yale

University, New Haven, Connecticut; and

WHEREAS, He then received a fellowship, training at New England Medical Center in Boston, Massachusetts, and earned his Ph.D. degree from London University in the United Kingdom; and

WHEREAS, Board certified in Internal Medicine, Hematology, Oncology, and Allergy-Immunology, Dr. Robert Taub has served as: Assistant through Associate Professor of Medicine, Mount Sinai School of Medicine, New York; Professor and Chairman of Medical Oncology, and American Cancer Society Professor of Clinical Oncology, Medical College of Virginia, Richmond; and Professor of Clinical Medicine and Co-Director, Columbia University Comprehensive Cancer Center; and

WHEREAS, As a leader in his profession, Dr. Robert Taub has proven himself to be a great asset to medicine and to the health and welfare of the citizens of the State of New York; and
