WHEREAS, As a coach's wife, Mary Carnesecca endured long separations from her husband as he built those incomparable St. John's teams; she supported him every step of the way, and he relied on the strength she provided to him; and

WHEREAS, Mary is the backbone of the Carnesecca family, a caring, wonderful partner who shares Lou's dreams and goals; perhaps the greatest legacy the Carnesecca's have created are the many relationships they have nurtured throughout the years; and

WHEREAS, Lou has an innate ability to make everyone he meets feel special, and his enthusiasm is infectious; a devoted wife and mother, Mary has always been ready to help those in need and unselfishly shared her husband with so many; and
