WHEREAS, In 1979, Vincent Proto earned his master's degree in banking from Hofstra, and was soon hired by Bankers Trust, now Deutsche Bank; he currently serves as vice president of risk analysis for this major institution; and

WHEREAS, Vincent Proto has been called upon to contribute his time and talents to countless civic and charitable endeavors and has always given of himself unstintingly; and

WHEREAS, In 1991, Vincent Proto began volunteering for the Mepham Alumni Association, and in 1993, he started coaching his children's

softball and baseball teams in the North Bellmore-North Merrick Little League, eventually becoming the organization's director; and WHEREAS, One year later, Vincent Proto joined the Mepham Sports Boosters Association, serving as president for three years and treasurer for three years; and

WHEREAS, Today, Vincent Proto remains an adviser to the Mepham Sports Boosters Association's executive committee while also volunteering for the Mepham Alumni Association, for which he has served as president and is now treasurer; and
