WHEREAS, In her role as principal executive for the General Services Administration's Northeast and Caribbean Region, she oversaw an annual operating budget of \$1.9 billion and a real estate portfolio that included 83 government owned buildings and leased space in 432 commercial locations; and

WHEREAS, Eileen Long-Chelales also served as Deputy Secretary for Administration and Operations in the Office of Governor George E. Pataki, a position she held for over two years; prior to 2002, she served as the Chief of Staff for Lieutenant Governor Mary O.
