WHEREAS, Sherry and Paul Durnan have been called upon to contribute their time and talents to countless civic and charitable endeavors and have always given of themselves unstintingly; and

WHEREAS, Paul is a lifelong member of St. Agnes Cathedral Parish where he serves as a Eucharistic Minister and a Lector; he is on the Telecare Board of Trustees and has been active in the fields of higher education and healthcare; and

WHEREAS, In 1985, Paul and Sherry Durnan entered the Equestrian Order of the Holy Sepulchre of Jerusalem and presently hold the rank of Knight and Lady Commander With Star; and

WHEREAS, In addition, Paul and Sherry Durnan were invested into the Order of Malta as Knight and Dame in 1997; since, they have participated in 13 Malta Lourdes Pilgrimages and several missions to the Malta Sacred Heart Hospital in Milot, Haiti; and

WHEREAS, In 2009, Paul and Sherry Durnan became the founding Co-Presidents of the Long Island Chapter of Legatos International, an organization striving to strengthen the faith of Catholic CEOs and their spouses; in 2009, they received the National Legatos Officers of the Year Award; and
