Senior Center, under the sponsorship of Bhrags; she was later employed as Director of the Fenimore Senior Center, where she developed and explored new horizons by presenting diverse opportunities such as the Helen Keller Senior Center for the Blind, the College Work Study Program and the District Attorney's Office-Community Service Program; and WHEREAS, In 1992, Ms. Smith served as interim employee at Van Dyke II Senior Center; in February 1993, Wayside Baptist Church became the new sponsor and she was appointed its Director, using her special talents and creative skills to develop a positive program; and WHEREAS, Under her leadership, Loretta Smith-Stanley has motivated and inspired seniors to participate in the day to day activities, such as a nutritional breakfast and lunch, educational and social activities, and entitlement services; and

WHEREAS, Loretta Smith-Stanley feels that one of her best attributes is counseling; she finds that counseling is an intricate tool that each senior needs for encouragement due to their special needs and most importantly, she finds that laughter and affection are joint ventures for herself as well as the seniors; and

WHEREAS, With her throughout have been her children, Lenika, Dienna, Jessica, and Vanessa, as well as two granddaughters, Appollonia and Chloe', all of whom feel privileged to be a part of her life and rejoice in her achievements; and
