WHEREAS, Each year Ulster-Greene ARC proudly honors outstanding members of the Ulster-Greene ARC community and other members of the community who give unselfishly of themselves to help make the lives of others fulfilling, recognizing them for their dedication to the community and their commitment to Ulster-Greene ARC's mission of offering people with intellectual and other developmental disabilities opportunities to live and experience full lives; and

WHEREAS, John Mizerak will be honored by Ulster-Greene ARC with the 2012 Humanitarian of the Year Award at its 31st Annual Humanitarian Awards Dinner to be held on Friday, May 18, 2012, at the Wiltwyck Golf Club, Kingston, New York in recognition and appreciation of his leadership; and
