WHEREAS, Soon after Anthony Carrow joined Omni Development, at the urging of brother, Charles Carrow; and

WHEREAS, On January 1, 2006, Charles and Anthony Carrow founded Carrow Real Estate Services; and

WHEREAS, Today, Carrow Real Estate provides a broad range of services in the areas of sales and leasing, property management, tenant/buyer representation, advisory services and green/LEED certification; and
WHEREAS, The company still operates from its original office at One Commerce Plaza and now has regional offices in Missouri and Pennsylvania; and

WHEREAS, Carrow Real Estate is truly a national real estate company, having been recognized by banks such as Wells Fargo; and
