WHEREAS, Linda Brown and Brenda Patch have participated in many endeavors on behalf of their community such as Clayton's Annual Christmas Parade, The Grindstone Island Research and Heritage Center's yearly Schoolhouse calendar fundraiser, and the annual planting of flowers each Memorial Day Weekend on the graves of those Grindstone Islanders who have no family left, carrying on a tradition started by their great grandmothers; and

WHEREAS, Linda Brown and Brenda Patch are most noted for their work on behalf of the annual Grindstone Island Quilt Show, consisting of over
