WHEREAS, In 1994, Donald E. Fane served as Vice President of C.D. Perry and Sons, a Heavy Civil and Marine Contractor, followed by President of King Road Materials, Inc., an Asphalt and Paving Company in 1995; and

WHEREAS, In 2000, Donald E. Fane became the President of Clemente Latham Concrete, as well as Senior Vice President of Callanan Industries, Inc.; and

WHEREAS, Donald E. Fane has been called upon to contribute his time and talents to countless civic and charitable endeavors and has always given of himself unstintingly; and

WHEREAS, He has been the recipient of countless awards, such as the 1999 Uncle Sam Citizen of the Year Award; Friends of 112th Street 2000 Humanitarian Award; 2003 Humanitarian Award from Sunny Side Center; the Troy Police Benevolent Association 2003 Gold Shield Award; and the 2006 Rensselaer County Good Scout Award; and
