WHEREAS, Robert J. Murphy was honored by the American Health Care Association with its 2006 Joseph Warner Patient Advocacy Award, and again in 2012, with their prestigious Advocacy in Action Award; moreover, he was recognized by NYSHFA/NYSCAL in 2007; and

WHEREAS, Robert J. Murphy served on the Board of the Empire State Society of Association Executives (ESSAE), a group for which he held the position of Chairman; in 1998, ESSAE presented him with its Vanguard Award in recognition of his exceptional leadership skills; and

WHEREAS, With a strong belief in the community, Robert J. Murphy has also served on a variety of charitable organizations including the Big Brothers and Big Sisters of Albany County which presented him with an award for his outstanding years of service; and

WHEREAS, An active parishioner at St. Pius X Church in Loudonville, New York, Robert J. Murphy has participated in numerous activities and has served on many committees; and

WHEREAS, Over the years, Robert J. Murphy has also served on various State Legislative and Executive Work Groups and Task Forces, focusing mainly in the area of long term health care; and

WHEREAS, With him throughout have been his wife, his two step sons, his son, and four grandchildren, all of whom feel privileged to be a part of his life and rejoice in his achievements; and
