WHEREAS, After graduation, Richard Sands returned home to Canandaigua to work for the family business; he spent time learning the business from his father from the ground up and after holding various positions, he was appointed executive vice president in 1982; and

WHEREAS, As a business leader, Richard Sands has always been willing to share his expertise, knowledge, and skills to help others grow and develop professionally; he also developed the family business through a number of acquisitions in the 1980s and 1990s; this growth has lead to Constellation Brands, Inc. being the world's leading wine company; and
