WHEREAS, This Legislative Body is justly proud to commend The Reverend Dr. John A. Credle, Jr. upon the occasion of celebrating his Sixth Anniversary as Pastor of Calvary Baptist Church of Red Hook; and

WHEREAS, As the esteemed senior pastor of the historical Calvary Baptist Church of Red Hook, The Reverend Dr. John A. Credle, Jr. is a third generation preacher in his family; and

WHEREAS, On Saturday, September 16, 2006, The Reverend Dr. John A. Credle, Jr. was called to be the fourth pastor in the sixty-five year history of the Calvary Baptist Church of Red Hook; in September 2012, he celebrated his sixth anniversary as the church's Pastor; and

WHEREAS, The Reverend Dr. John A. Credle, Jr. began the ministry of preaching the gospel on Sunday, September 8, 1996, under the tutelage of Reverend Dr. Spurgeon E. Crayton, Senior Pastor of the Mount Ollie Baptist Church in Brooklyn, New York; and

WHEREAS, On November 22, 1998, The Eastern Baptist Association of New York ordained Reverend Credle to gospel ministry; he had begun his first pastoral assignment in February of 1997; in June 1999, the True Deliverance Church he founded as a mission was officially established as a church; and

WHEREAS, Prior to his full time engagement in the ministry, The Reverend Dr. John A. Credle, Jr. was employed by the New York City Department of Education and by the Federal Aviation Administration; and

WHEREAS, The Reverend Dr. John A. Credle, Jr. attended Fisk University in Nashville, Tennessee; he graduated with a Bachelor of Science degree in Law and Paralegal Studies from the City University of New York; and WHEREAS, Currently, The Reverend Dr. John A. Credle, Jr. is in graduate school at the Union Theological Seminary/Columbia University in New York City, where he is a Master of Divinity Candidate for the year of 2013; and

WHEREAS, In addition, The Reverend Dr. John A. Credle, Jr. intends to obtain his Doctorate of Ministry degree; he has also completed clinical pastoral education at the Jewish Theological Seminary and holds two certificates of completion from accredited Bible schools; and

WHEREAS, The Reverend Dr. John A. Credle, Jr. grew up in the Brownsville section of Brooklyn, New York; he is married to Cheron Diedra Credle; together they are the proud and loving parents of four children, Joshua Prince, Jordan Grace, Victory Johanna and Zoe Sonia; and

WHEREAS, It is the sense of this Legislative Body that when a person of such noble aims and accomplishments is brought to our attention it is appropriate to publicly and jubilantly proclaim and commend that individual for the edification of others; now, therefore, be it
