WHEREAS, Known as the heart of the Zonta Club of Albany, Carol Tomlin has worked for many years with fellow Committee members to organize and lead the Club's memorial service for Zontians and their families; during the holidays and in the Spring, she decorates the Albany Memorial Hospital Chapel with beautiful flowers; and

WHEREAS, Carol Tomlin has supported Father Peter Young's homeless program at the Schuyler Inn for many years; she has organized craft activities for the children of families living at the Inn, and offers gentle and positive encouragement to the homeless; and WHEREAS, In addition, Carol Tomlin has helped deliver clothing and furniture to the Capital City Rescue Mission, as well as to women of The Next Step, a program that empowers women with alcohol and drug addictions to begin and sustain a life-long process of recovery through residential treatment and supportive living services; and WHEREAS, Throughout Summer and Fall, Carol Tomlin hosts "sew what" gatherings to prepare items to be sold for fundraising at the Academy of Holy Names and the Empire State Plaza Holiday Craft Fairs; she graciously provides wonderful lunches and opportunities for great fellowship; and
