WHEREAS, In his official acts, Judge Richard O'Callaghan was governed by a keen sense of duty and always showed a unique grasp of human problems; and

WHEREAS, In addition to his judicial post, this remarkable man has devoted countless hours to civic and community activities; he has conducted seminars and mock trials at New York University, St. John's Episcopal Hospital, the Suffolk County Podiatry Association and the Suffolk County Medical Society; furthermore, he has also lectured on trial techniques for the Nassau Academy of Law, and participated in the Lawyer in the Classroom program; and
