WHEREAS, For the past 50 years, Gerald N. Jacobowitz has distinguished himself in the practice of law, earning the admiration, esteem and affection of his colleagues, peers, community and clients; and

WHEREAS, Gerald N. Jacobowitz is a graduate of Colgate University, magna cum laude - Phi Beta Kappa, and received his Juris Doctor degree in 1958 from the New York University School of Law, where he was a John Ben Snow Root Tilden Scholar; he was admitted to the New York State Bar in 1959 and is admitted to practice in the United States District Court for the Southern and Eastern Districts of New York, the United States Court of Appeals, 2nd Circuit and the United States Supreme Court; and
