participated in the Horse Bowl for many years, rising to become a member of the district team and subsequently being awarded the position of Captain of the New York State Horse Bowl Team; and

WHEREAS, Wilder Johnson's leadership abilities have expanded and grown through his involvement in 4-H activities; he has participated in a number of 4-H statewide leadership trips, and has been a member of the planning team for the state teen leadership retreat for the past two years; and

WHEREAS, In addition, he is an excellent public speaker, and has done an outstanding job serving as MC for the 4-H Achievement Night; and

WHEREAS, This Legislative Body is moved to honor Wilder Johnson, a young man and able scholar, recognizing the value of his labors and the promise of his future; now, therefore, be it
