WHEREAS, A proponent of learning, Neil Yeoman has attended Nassau Community College since his retirement in 2001 as an auditing student under New York State's Senior Citizen Observer Program; and

WHEREAS, Neil Yeoman was employed as a Chemical Engineer for more than

four illustrious decades; for 11 years he worked as the Process Manager in charge of designing chemical processing plants, and 14 years as a Research and Development Director at a chemical processing equipment supplier; he also spent eight years as a Vice President and Chief Chemical Engineer of an engineering and construction company, and has been a member of the American Institute of Chemical Engineering since 1956; and WHEREAS, Neil Yeoman has been called upon to contribute his time and talents to countless civic and charitable endeavors and has always given of himself unstintingly; and

WHEREAS, Throughout the entire period of his community service, a period of constructive involvement, Neil Yeoman has stood constant in dignity, good grace and humor; and
