WHEREAS, The recipient of numerous awards and commendations for his outstanding service, Lieutenant Luis Alvarez was honored with the Firemen's Life Saving Award and the Sullivan County Shield's Life Saving Award for his heroic actions in rescuing a man who was drowning in the Delaware River; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Lieutenant Luis Alvarez has displayed throughout his career; and
