WHEREAS, In 2003, Chairman Liu Wei proudly played a vital organizational role in the first International United States Police Conference in the history of China; and

WHEREAS, As part of a NPDF Delegation, Chairman Liu Wei was honored to privately meet and exchange ideas with Pope Benedict XVI in December of 2007; and

WHEREAS, Throughout his career in the security and police force industry, Chairman Liu Wei prided himself on both his efficiency and strong work ethic; for his invaluable expertise, he has been the recipient of numerous awards and accolades; and

WHEREAS, With him throughout has been his wife, Xin Wang, and his daughter, Kayi Lau, both of whom feel privileged to be a part of his life and rejoice in his achievements; and
