Side, Magee Hickey recently returned to her birth city; she attended both the Chapin School and Convent of the Sacred Heart in New York City, and graduated from Brown University, Providence, Rhode Island; and WHEREAS, Magee Hickey was the first host of the weekend edition of "TODAY" with Matt Lauer, and an Emmy Award winning reporter whose pieces have made a significant difference in the lives of all New Yorkers; today, she is a News Reporter for WPIX Channel 11; and WHEREAS, Magee Hickey was honored as Mother of the Year by the National Mother's Day Council, and was listed as one of the Top 100 Irish Americans by IRISH AMERICAN MAGAZINE; and WHEREAS, Active within her community, Magee Hickey is a vital member of The American Cancer Society and The Kennedy Child Center, as well as the Lawrence F.
