WHEREAS, Today, the Sixth Avenue Senior Center offers daily congregate meals; social service referral and case management; medical and health related workshops and screenings; monthly birthday parties; music, dancing, arts and crafts classes; and field trips; as well as other educa-

tional and recreational activities; and

WHEREAS, In addition, the Sixth Avenue Senior Center coordinates community meetings, assists senior members in meeting their housing needs, promotes voter registration and educates the community on the importance of exercising their voting rights; and

WHEREAS, The aforementioned activities as well as other special functions all aim to enhance the overall quality of life among the senior population within the district; and

WHEREAS, The Sixth Avenue Senior Center truly enhances the overall quality of life among the senior population and is an asset within the community it so ably serves; and

WHEREAS, This significant milestone is an excellent opportunity to recognize the special contributions of the Sixth Avenue Senior Center and the dedicated individuals who strive to better the quality of life for senior citizens in the community; and

WHEREAS, It is the sense of this Legislative Body that when organizations of such noble aims and accomplishments are brought to our attention, they should be celebrated and recognized by all the citizens of this great Empire State; now, therefore, be it
