WHEREAS, This vital organization has hosted a series of fundraisers including Ladies' Day Card Parties, holiday shopping events, and Casino Nights; David Jaslow is responsible for almost every aspect of the planning for these events, including selecting locations, creating invitations, promoting attendance through social media and mass email marketing, maintaining guest lists, and selling sponsorships and advertising; he also recruits fellow high school students to solicit raffle prizes and stuff goody bags; and

WHEREAS, The success of the State of New York, the strength of our communities, and the vitality of American society depend, in great measure, upon the dedication of young people like David Jaslow, who use their considerable talents and resources to serve others; and
