WHEREAS, The Ossining Children's Center, a nonprofit child care center, was founded in 1895 to provide educational and enriching care to the children of immigrant women whose husbands were killed or disabled while working on the railroad or the Croton Aqueduct; and

WHEREAS, Today, this vital organization cares for more than 160 children, ages eight weeks through grade five, and offers a variety of early childhood and school age programs; the center also provides a full-day camp for preschoolers and school-age youngsters in the summer, as well as a variety of enrichment programs including a summer film animation workshop, gardening program, gymnastics and music; and

WHEREAS, Remaining true to its mission, the Ossining Children's Center provides care for children in a safe, nurturing, and enriching environment, creating a foundation for life-long intellectual, social, emotional and physical growth, and serving as a community resource and advocate for families; and

WHEREAS, The success of the Ossining Children's Center is in direct correlation to the efforts of its staff, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and an uncompromising standard of excellence in all endeavors;
