WHEREAS, Florence Monwe also attended the institute of Management and

Technology in Enugu-Nigeria, where she obtained a Higher National Diploma in Business Administration and Management; and

WHEREAS, In June of 1991, Florence Monwe migrated to the United States and met her future husband, Lawrence Monwe; she was employed as a Case-worker with New York City, working with the Foster Care Department of New York City Administration for Children Services (ACS); and

WHEREAS, Florence Monwe took the New York State Bar Examination, and was called to the New York Bar Association in 1999; she volunteered her services working Pro Bono for the New York State Legal Aid Society in Queens, New York, from 1999-2000; and

WHEREAS, On July 27, 2000, Florence Monwe held the esteemed position of Administrative Law Judge for Child Abuse at the New York State Office of Children and Family Services; a title she still holds today; and

WHEREAS, With her throughout have been her husband, Lawrence (Larry) Monwe, and her three sons, Raluchukwu, Jachike, and Chukwuemeka, all of whom feel privileged to be a part of her life and rejoice in her achievements; and
