WHEREAS, In 1981, 1995, 1996, 1997, and 1998, Anthony Raccomandato was instrumental in helping the Piston Knocker Drill Team capture the New York State Drill Team Championship; and

WHEREAS, A resident of Babylon, New York, Anthony Raccomandato has served on several committees, and is presently a Trustee for the North Lindenhurst Fire Department; and

WHEREAS, With him throughout have been his wife, and their two sons, whom feel privileged to be a part of his life and rejoice in his achievements; and
