WHEREAS, Steve Peterson has been called upon to contribute his time and talents to countless civic and charitable endeavors and has always given of himself unstintingly; and

WHEREAS, Through his work with the Braves Travel Baseball Organization, Steve Peterson has given young athletes the opportunity to give back to their communities through both sponsorship and volunteering at events including the Bethlehem Turkey Trot which benefits the Bethlehem Food Pantry; and

WHEREAS, The Braves Travel Baseball Organization also sponsors a proud Bethlehem tradition, hosting the Annual 4th of July Vintage 1864 Baseball game, a highlight of the Town Park's Fourth of July Family Celebrations; and

WHEREAS, Steve Peterson has further demonstrated his commitment to improving community life by developing the Bethlehem Youth Sports Council and the Heads UP Safe Sports, which raises awareness and provides education on the importance of safety in the world of sports; and
