WHEREAS, This Legislative Body is justly proud to honor Matthew Romano upon the occasion of his designation as recipient of a 2015 Chancellor's Award for Student Excellence on Thursday, April 2, 2015; and

WHEREAS, The Chancellor's Award for Student Excellence is the highest student recognition in the State University of New York (SUNY) system; and

WHEREAS, The State University of New York is the largest comprehensive university system in the United States, educating more than 468,000 students in more than 7,500 degree and certificate programs on 64 campuses, with more than 3 million alumni around the globe; and

WHEREAS, The Chancellor's Award for Student Excellence was created in 1998 to recognize students who have demonstrated, and have been recognized for, the integration of academic excellence with accomplishments in the areas of leadership, athletics, community service and performing arts or career achievement; and

WHEREAS, Students honored with the Chancellor's Award for Student Excellence, such as Matthew Romano who attends SUNY Orange, truly embody the power of SUNY; as proven leaders and role models, scholar athletes, creative artists, and civic volunteers, each student is recognized not just for academic achievement, but also for the profound impact they have on college campuses and local communities across New York State; and
