ities, Rasheen Powell's ongoing efforts and notable achievements have significantly contributed to bettering the quality of life in his community; and

WHEREAS, The success of the Collins Correctional Facility is in direct correlation to the efforts of Rasheen Powell, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and an uncompromising standard of excellence in all endeavors on behalf of this vital institution and the community it serves; and
