WHEREAS, Dr. Pamela V. Agan-Smith's work as a school psychologist has had a positive, wide-ranging effect on the youth of Greenville, helping them succeed both inside and outside the classroom; and

WHEREAS, Throughout the entire period of her community service, a period of constructive involvement, Dr. Pamela V. Agan-Smith has stood constant in dignity, good grace and humor; and
