WHEREAS, In addition, this esteemed woman is a member of the Independent Judicial Qualifications Committee, and has worked as a delegate and campaign coordinator/consultant on numerous political campaigns; and

WHEREAS, Anne B. McDonald has been called upon to contribute her time and talents to countless civic and charitable endeavors and has always given of herself unstintingly; she is the former Board Chair of the

Hudson River/Black River Regulating District, and a member of the North Country Community College Foundation Board and Board of Directors; and

WHEREAS, Furthermore, Anne B. McDonald has provided her support to numerous worthy causes including the Heritage Museum, the Lake George Association, and the Friends of Fort Ticonderoga; and
