tions, such as Junior Class President as well as President her senior year; and

WHEREAS, Upon graduating, Alexandria Hart earned her degree in Economics from Fordham University, New York City, concurrently working at J.P. Morgan; throughout her 15-year tenure, she has served in several units, including Investment Banking Training, and development and campus recruiting; and
