WHEREAS, Robert Scott has been called upon to contribute his time and talents to countless civic and charitable endeavors and has always given of himself unstintingly; and

WHEREAS, Known for his dedication to helping others, Robert Scott has been a member of the Senior Council, and has served on its Board of Directors for many years; he is also a member of the Orange County Senior Games Committee, spending many hours planning and coordinating various events; and

WHEREAS, In addition, Robert Scott is a member of the Office of the Aging's RSVP Council, where he assists seniors with challenging, rewarding, and significant volunteer service opportunities; and

WHEREAS, A member of numerous civic and professional organizations, Robert Scott currently serves as Chairman of the Village of Florida Planning Board, and Adjutant at the American Legion Post No. 1250; he is also a member of the Florida Historical Society and the Seward Homestead Restoration Committee; and

WHEREAS, Throughout the entire period of his community service, a period of constructive involvement, Robert Scott has stood constant in dignity, good grace and humor; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Robert Scott has displayed throughout his life; and

WHEREAS, With him throughout have been his wife, Nancy, and his son, Matthew (Megan), as well as his grandson, Ben, all of whom feel privileged to be a part of his life and rejoice in his achievements; and
