WHEREAS, In addition, John Cappello works with the Josephine-Louise Library in Walden, offering resources to individuals within the community to educate them and to enhance their lives; and

WHEREAS, John Cappello has spent his illustrious career in law as a steadfast and tireless advocate for those in need of affordable housing in the region; he also serves on the Pattern for Progress Affordable Housing Committee; and

WHEREAS, Throughout the entire period of his community service, a period of constructive involvement, John Cappello has stood constant in dignity, good grace and humor; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which John Cappello has displayed throughout his life; and
