WHEREAS, Carolyn Reilly has been an integral part of the National External Diploma Project for the past five years; she has been instrumental in assessing many students in a program which allows the students to earn a local high school diploma; and

WHEREAS, In addition to her duties as an assessor, Carolyn Reilly has conducted orientations and local marketing for the program; her insight and expertise as a counselor make her an invaluable asset to the National External Diploma Program as she is able to counsel completed students with regard to their future educational goals; and
