WHEREAS, Elmer Mendez is a champion wrestler in the 220-pound weight class; he earned a trip to the New York State Wrestling Championships, and will continue his wrestling career at the State University of New York at Brockport in the fall; and

WHEREAS, The athletic talent displayed by these two standout athletes is due in great part to the efforts of Coach Anthony Schettino, a skilled and inspirational tutor, respected for his ability to develop potential into excellence; and

WHEREAS, The overall record of these two fine wrestlers is outstanding, and they were loyally and enthusiastically supported by family, fans, friends and the community at large; and

WHEREAS, The hallmarks of Sam Goldman and Elmer Mendez, from the opening match of the season to participation in the Championships, were prime examples of athletic ability, of good sportsmanship, of honor and of scholarship, demonstrating that these two student-athletes are second to none; and

WHEREAS, Athletically and academically, Sam Goldman and Elmer Mendez have proven themselves to be an unbeatable combination of talents, reflecting favorably on their school; and

WHEREAS, Sports competition instills the values of teamwork, pride and accomplishment, and Coach Anthony Schettino and these two outstanding athletes have clearly made a contribution to the spirit of excellence which is a tradition of their school; now, therefore, be it
