WHEREAS, Throughout the entire period of her community service, a period of constructive involvement, Mary Cipriano-Walter has stood constant in dignity, good grace and humor; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Mary Cipriano-Walter has displayed throughout her life; and

WHEREAS, It is the sense of this Legislative Body that when individuals of such noble aims and accomplishments are brought to our attention, they should be celebrated and recognized by all the citizens of this great Empire State; now, therefore, be it
