WHEREAS, This Legislative Body is justly proud to honor Nicholas J. Faso upon the occasion of his designation as recipient of the Paul J. WHEREAS, Furthermore, in his final year, Nicholas J. Faso along with his co-counsel were the winners of the Karen C. McGovern Senior Prize Trials, a year-long trial advocacy competition; and

WHEREAS, Nicholas J. Faso is an Associate with Whiteman, Osterman & Hanna, LLP, where his principal area of practice is commercial litigations; he is admitted to practice in New York State, and is a member of both the Albany County Bar Association and the New York State Bar Association; and

WHEREAS, An avid volunteer, Nicholas J. Faso has provided pro bono representation to prisoners challenging disciplinary determinations; he also currently serves on the Boards of the Albany Symphony Orchestra and the Albany Academy Alumni Association; and

WHEREAS, Throughout the entire period of his community service, a period of constructive involvement, Nicholas J. Faso has stood constant in dignity, good grace and humor; and
