the Park, a Preschool Program, Tennis and Swim Lessons, Holiday Homes, Winterfest, Senior Activities, and the Spotlight on Youth Awards; and WHEREAS, Vicky DeJulio sat as a member on both the East Greenbush Youth Commission and the Rensselaer County Advisory Committee; she chairs a Peer Leadership Club at Columbia High School, and in 2001, she received recognition from Rensselaer County and East Greenbush Central School District for her steadfast community service; and

WHEREAS, A truly endearing woman, Vicky DeJulio, in her official acts, is governed by a keen sense of duty and always shows a unique grasp of human problems, earning the admiration, esteem and affection of her colleagues; and
