WHEREAS, A steadfast and unrelenting environmental advocate, Fran Martino's work includes developing, planning and presenting educational and recreational programs for the general public, schools, scouts, town parks, day camps and other organizations; and

WHEREAS, Fran Martino spearheaded the Alliance's "Stream Spotter" program to train community volunteers to monitor water quality throughout the Greater Stockport Creek Watershed; and

WHEREAS, In addition, Fran Martino serves the New York State Department of Health Fish Advisory Outreach Project where she has been instrumental in raising awareness on fish consumption from New York State waters; and

WHEREAS, Throughout the entire period of her community service, a period of constructive involvement, Fran Martino has stood constant in dignity, good grace and humor; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Fran Martino has displayed throughout her life; and

WHEREAS, It is incumbent upon all citizens to recognize and applaud the efforts of individuals such as Fran Martino who work tirelessly on behalf of protecting our natural surroundings for the benefit of present and future generations of New Yorkers; now, therefore, be it
