WHEREAS, Throughout his illustrious tenure, Robert Vecchio has served with loyalty, honor, and distinction while helping the young people of his community and contributing to the rise of the William Floyd School District's graduation rate to 80 percent; and

WHEREAS, Robert Vecchio has also helped his district develop an in-house career and technical education program to give teenagers instruction for careers in six fields: automotive technology, business, carpentry, cosmetology, culinary arts and medical assisting; the program's enrollment has grown to 200 students since its inception three years ago; and

WHEREAS, Furthermore, Robert Vecchio is credited with spearheading the Town of Brookhaven's first "Our Community Salutes" program to recognize high school graduates who have proudly served their country as members of the United States Armed Forces; and

WHEREAS, Robert Vecchio has been called upon to contribute his time and talents to countless civic and charitable endeavors and has always given of himself unstintingly; he graciously serves on the Brookhaven Town Ethics Board in addition to his many other duties; and
