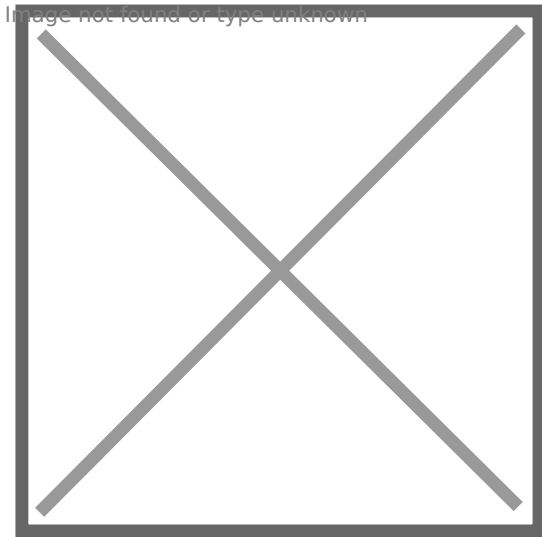

**This Week's Featured Regulations**

**Federal Register, Volume 80, Issue 152, August 7, 2015:**

- **Occupational Exposure to Beryllium and Beryllium Compounds (Occupational Safety and Health Administration (OSHA)/OSHA-H005C-2006-0870)**
  - OSHA proposes to amend its existing exposure limits for occupational exposure in general industry to beryllium and beryllium compounds. The proposed regulation will enact a new permissible exposure limit (PEL) as well as enact provisions for employees protection.
  - The public comment period ends on November 5, 2015.

**New York State Register, Issue 32, August 12, 2015:**

- **Petroleum Products and Delivery Devices; Exemption of Maple Syrup and Honey Producers from Food Processing.**

**(NYS Department of Agriculture and Markets/AAM-32-15-00001-P)**

- The rule will repeal requirements relating to petroleum devices and products, and to maple syrup and honey producers.
- Public comments will be accepted for 45-days or up to September 26, 2015.

- **Registration of Manufacturers, Distributors, Wholesalers, Various Retailers of Sparkling Devices.**

**(NYS Division of Homeland Security and Emergency Services/HES-32-15-00002-EP)**

- The rule will establish the registration process, fees and reporting requirements related to sparkling devices.
- Public comments will be accepted for 45-days or up to September 26, 2015.

**Federal Register, Volume 80, Issue 156, August 13, 2015:**

- **Extension of Time to File Certain Information Returns (Internal Revenue Service/REG-132075-14)**

- The IRS is issuing temporary regulations that will remove the automatic extension time to file information returns on forms in the W-2 series (except Form W-2G). The temporary regulations will allow only a single 30-day non-automatic extension of time to file these information returns.
- The public comment period ends on November 12, 2015.
