Chair of the Happiness House Foundation; currently, he serves as the Chair of the Board of Trustees of Keuka College and the Lyons Community Health Initiative Corporation; and

WHEREAS, Moreover, "Bob" A. Schick has served as Chair of the Geneva Chamber of Commerce, the Independent Bankers Association of New York and the New York Bankers Association Retirement System; he was also a former member of the Smith Opera House Board of Trustees, Treasurer of Lyons Industrial Development Agency and Treasurer of the FLCC Foundation; and

WHEREAS, With him throughout have been his two loving daughters, Danielle and Dawn, and his granddaughter, Emilee, all of whom feel privileged to be a part of his life and rejoice in his achievements; and
