WHEREAS, With him throughout have been his wife of 32 years, Mary Jane, and their children, Michael, Julie, Amy, Jon, Katie, David, Courtney and Andrew, as well as 15 grandchildren, all of whom feel privileged to be a part of his life and rejoice in his achievements; and
