LEGISLATIVE RESOLUTION commending STRIDE Adaptive Sports upon the occasion of hosting its 11th Annual Wounded Warrior Snowfest, March 3-6, 2016

triumphs made possible through STRIDE's therapeutic Wounded Warrior programs; and

WHEREAS, For over 30 years, STRIDE Adaptive Sports has been dedicated to enriching the lives of individuals with disabilities through recreational and athletic activities; throughout its 11 years of service to Wounded Warriors, this vital organization has transformed the lives of veterans through a variety of adaptive sports activities, a supportive community, and an innovative mentoring program which pairs recently injured veterans with youths who have similar disabilities; and

WHEREAS, STRIDE Adaptive Sports stands behind its mission that no one should be left behind because of a disability; it is possible to remove boundaries, fulfill dreams, enhance self-esteem, and empower youth with disabilities through participation in sport and fun activities; and
